The water/sewer billing is mailed at the beginning of each month payable in advance for Historic Olivehurst. The **water** is **\$21.50** per month and **sewer** is **\$25.00** per month for a total of **\$46.50 per month** per single-family dwelling. For River Glen, Mapleton, Heartlands, and residents retrofitted with meters, the rate is as follows: **water** is **\$15.00** per month for 20 CCF, usage above that is at the rate of \$0.77 per CCF consumed. Our **sewer** is a flat rate of **\$25.00** per month. Payment is due and payable upon receipt. A penalty of 10% of the unpaid balance will be applied if not paid before the due date. If your account has not been paid by the **25<sup>th</sup>** of the following month your account will be considered delinquent and a **\$50.00 delinquency fee** will be assessed to your account, services will be discontinued, and a deposit of \$76.50 may be required.

Plumas Lake, Summerfield, and Wheeler Ranch water is metered and based on usage. Bills will be mailed approximately the 15<sup>th</sup> of the month. The **water** is **\$15.00** per month for 20 CCF usages above that is at the rate of \$0.77 per CCF consumed. Our **sewer** is a flat rate of **\$25.00** per month. Payment is due and payable upon receipt. A penalty of 10% of the unpaid balance will be applied if not paid before the due date. If your account has not been paid by the **10<sup>th</sup>** of the following month your account will be considered delinquent and a **\$50.00 delinquency fee** will be assessed to your account, services will be discontinued, and a deposit of \$76.50 may be required.

If you move out of the Olivehurst Public Utility District please notify the OPUD Business office to close your account in writing. If you do not notify the OPUD Business office your service will continue in your name and incur charges.
