RESOLUTION NO. 2290

A RESOLUTION OF THE BOARD OF DIRECTORS OF
THE OLIVEHURST PUBLIC UTILITY DISTRICT IDENTIFYING THE TERMS
AND CONDITIONS FOR FIRE DEPARTMENT RESPONSE AWAY FROM THEIR
OFFICAL DUTY STATION AND ASSIGNED TO AN EMERGENCY INCIDENT
OUTSIDE OF THEIR JURISDICTION.

WHEREAS, the Olivehurst Public Utility District is a public agency located in the County of Yuba, State if California, and

WHEREAS, the Olivehurst Public Utility District (the "District") routinely responds to requests for assistance to incidents outside the jurisdiction; and

WHEREAS, the request for resources to respond for assistance may be through an "Assistance for Hire" arrangement; and

WHEREAS, the District may be compensated for resources provided or reimbursed for response expenses through such agreements; and

WHEREAS, it is the District's desire to provide fair and legal payment to all its employees for time worked; and

WHEREAS, the District has in its employ the following Fire Department response personnel, which include: Fire Chief, Assistant Chief, Captain, Engineer, Apparatus Operator, Firefighter/EMT and Firefighter; and

WHEREAS, the District will compensate its employees for all time committed, portal to portal, while in the course of their employment and away from their official duty station and assigned to an emergency incident, in support of an emergency incident, or pre-positioned for emergency response; and

WHEREAS, the District will compensate its employees overtime in accordance with their current Memorandum of Understanding while in the course of their employment and away from their official duty station and assigned to an emergency incident, in support of an emergency incident, or pre-positioned for emergency response.

NOW, THEREFORE, BE IT RESOLVED by the Board of Directors of the Olivehurst Public Utility District that:

1. Personnel shall be compensated according to Memorandum of Understanding (MOU), Personnel Rules and Regulations, and/or other directive that identifies personnel compensation in the workplace.

2. In the event a personnel classification does not have an assigned compensation rate, a "Base Rate" as set forth in an organizational policy, administrative directive or similar document will be used to compensate such personnel.
3. The Olivehurst Public Utility District will maintain a current salary survey or acknowledgement of acceptance of the "base rate" on file with the California Governor's Office of Emergency Services, Fire Rescue Division.
4. Personnel will be compensated beginning at the time of dispatch until the return to jurisdiction and all equipment and personnel are back in service and available for agency response (for all time committed portal to portal).
5. Fire Department response personnel include: Fire Chief, Assistant Chief, Captain, Engineer, Apparatus Operator, Firefighter/EMT and Firefighter.


