RESOLUTION NO. 2199

**A RESOLUTION OF THE BOARD OF DIRECTORS OF THE
OLIVEHURST PUBLIC UTILITY DISTRICT CERTIFYING
PARCELS WHEREIN THE PRESENCE OF NOXIOUS WEEDS AND
RUBBISH, OR OTHER LITTER, RENDER THEM A PUBLIC SAFETY.**

WHEREAS, the Board of Directors of Olivehurst Public Utility District did, on September 21, 2008, adopt its Resolution No. 2187, establishing a program for the abatement of weeds, rubbish and other nuisance materials within the District in accordance with the provisions of Part 5 of Division 12, commencing with Section 14879, of the Health and Safety Code of the State of California; and

WHEREAS, the Board of Directors of the District has received from the Fire Chief of the District a certification of those parcels, streets, and sidewalks, wherein the presence of noxious weeds and rubbish, or other litter, that render them a public safety hazard to the likelihood of fire and injury to human life is present; and

WHEREAS, the Board of Directors of Olivehurst Public Utility District does hereby find such nuisance exists and does intend to establish by resolution its order for abatement thereof in accordance with the provisions of law.

NOW, THEREFORE, BE IT RESOLVED by the Board of Directors of Olivehurst Public Utility District, as follows:

1. Weeds, as defined in Resolution No. 2187, are growing upon and within those certain streets, sidewalks, and on private property within the boundaries of the District.
2. Said weeds, constitute a public nuisance in that they present a risk of fire hazard or other risk to human life and they must be abated.
3. The notice to be issued by the Fire Chief in connection with the destruction of weeds shall be that Notice set forth in Exhibit "A," attached hereto and by this reference incorporated.
4. The streets and roads upon which the nuisance exists, and/or upon which the sidewalks wherein said nuisance exists are located, are named in Exhibit "B," attached hereto and by their reference incorporated.
5. The parcels of private property are further described by tract, block, lot, code area and parcel number as used in the records of the District or the assessor of Yuba County in Exhibit "B," attached hereto and by this reference incorporated.
6. The Board of Directors of Olivehurst Public Utility District hereby designates the Fire Chief of the Olivehurst Public Utility District Fire Department as the person authorized to give notice to destroy weeds in accordance with the provisions of Chapter 3 of Part 5 of Division 12, commencing with Section 14879, of the Health and Safety Code of the State of California.

7. Notice shall be provided to the landowners affected thereby by mailing to the property owners as their names and addresses appear from the last equalized assessment roll of the County of Yuba, or as they are otherwise known to the Clerk of the Board of Directors of Olivehurst Public Utility District.
8. Alternatively, the Notice may be provided by posting copies of the Notice on the property upon which the nuisance exists, at a distance of not more than 100 feet apart, with at least one such Notice posted on each parcel and publication in accordance with the provisions of Health and Safety Code 14895.
9. Hearings on said notices shall be scheduled at the Board of Directors Meeting to be held on June 18, 2009 (at least 10 days notice).
10. At said hearing, the Board shall make the findings and determinations set forth in Part 5 and Board action thereon shall be considered final, and the Board shall act by resolution to authorize the abatement action.


