# RESOLUTION OF THE BOARD OF DIRECTORS OF OLIVEHURST PUBLIC UTILITY DISTRICT ESTABLISHING REIMBURSEMENT FEES FOR DEVELOPMENT REVIEW AND CONSULTATION BY OPUD STAFF

WHEREAS, Olivehurst Public Utility District is a public utility district formed and existing in accordance with the provision of Division 7 of the Public Utilities Code of the State of California; and

WHEREAS, the intense pace of development within the District frequently requires that the District's staff, and District legal and engineering consultants, devote time and expertise to assist developers in the review of proposed developments, preparation and/or review of engineering studies and plans, drafting, review, and revision of legal documentation, which services should not be funded from general funds of the District and which services do not benefit utility customers of the District; and

WHEREAS, it is the policy of the Board of Directors of the District to charge those who benefit from the direct and indirect costs of the District attributable to OPUD staff consultation, consultation with OPUD contract District Engineer, outside consultants, and costs of administration of accounts and related expenses associated with these actions; and,

WHEREAS, the District's costs of consultants are normally recovered through advance funding agreements with developers but the direct and indirect costs of District employees have not been charged under such agreements; and

WHEREAS, the Board of Directors of Olivehurst Public Utility District desires to establish a schedule of fees and charges by which special services required for OPUD staff consultation, consultation with OPUD contract District Engineer, administration of accounts and related expenses associated with these actions.

**NOW, THEREFORE, BE IT RESOLVED** that the District shall levy charges against the entity requiring staff special services in accordance with the schedule of charges described exhibit A.

**BE IT FURTHER RESOLVED** that the schedule of rates and charges applicable to the foregoing described services represents the District's best estimate of the out-of-pocket costs

incurred by the District on an average basis to provide said services, which costs shall be collected through a deposit prior to services being rendered.

**BE IT FURTHER RESOLVED** that Exhibit "A" is subject to amendment from time to time by the Board of Directors of the District determines it is required.
