#### Item description/summary:

Consider approving the requests by 2 Tall Sweet Treats for modifications to Eufay Woods Sr. Park.

Food vendor, 2 Tall Sweet Treats, has offered to donate money to purchase 2 picnic benches that they would like placed neat the parking lot off Zanes at Eufay Woods Sr. Park. These benches would be put near the entrance closest to the lift station. The reason for the request is so that the patrons of their business could have seating while enjoying the food and beverages they have purchased from 2 Talls. Should 2 Talls provide the seating, they would also have to provide a restroom and running water. I have verified with the county that if OPUD allows the business to sell at their property and offers a public restroom and the business has running water, could the business then provide their own portable tables and chairs, to which the county was amenable.

- 2 Talls has also requested the following be added to their request for tables:
- 1. If the proposal is approved by the Board, what would be the estimated timeframe for the installation of the seats, benches, and tables?
- 2. Is OPUD P open to contributing towards the cost of the build? We believe a joint effort could potentially expedite the process and enhance the overall outcome.
- 3. We are considering the inclusion of a cemented pathway that is wheelchair accessible, as well as a wheelchair-accessible table. Would this be feasible within the project scope?
- 4. Additionally, we are contemplating the idea of a covered area to provide shelter during inclement weather. Would this be a possibility?
- 5. Lastly, would we be permitted to acknowledge our contribution to the project? For instance, could we have a plaque or branding on the table, such as "Tables donated by 2Talls Sweet Treats" or "The Cummings family"

Hi Bri,


