Item description/summary: Restroom Agreement – Rosie’s Hand Dipped Corn Dogs

Yuba County is requiring Rosie’s Hand Dipped Corn Dogs food truck to obtain a restroom agreement with OPUD. Rosie’s parks on Zanes Dr. next to Eufay Woods Sr. Park in Plumas Lake to conduct business. They are not using OPUD property to conduct their food sales but are on county-maintained roadway. Rosie’s is asking OPUD to enter into a restroom agreement that will allow their employees to use the bathroom facilities at Eufay Woods Sr. Park during the few hours they are conducting their business on Zanes Dr. The agreement requires that OPUD maintain the facilities in good working order, which is already done by OPUD staff, and informs OPUD that the facilities are subject to inspection by Yuba County Environmental Health.

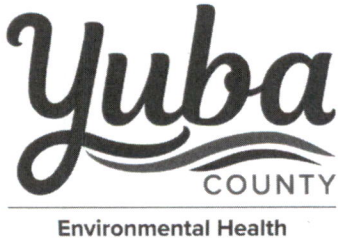
