A RESOLUTION OF THE BOARD OF DIRECTORS
OF THE OLIVEHURST PUBLIC UTILITY DISTRICT
DIRECTING AND AUTHORIZING A REPRESENTATIVE
TO ENTER INTO A FINANCIAL ASSISTANCE AGREEMENT
WITH THE STATE WATER RESOURCE CONTROL BOARD
FOR THE PLANNING, DESIGN, AND CONSTRUCTION OF
THE OLIVEHURST PRIVATE SEPTIC TO SEWER
CONVERSION PROGRAM

WHEREAS, the Olivehurst Public Utility District (OPUD) provides sewer services to the communities of Olivehurst and Plumas Lake in Yuba County, CA.

WHEREAS, the OPUD sewer system consists of twenty lift stations and serves a population of roughly 30,000 with 170 commercial metered connections, 19 industrial metered connections, and 8,000 residential metered connections.

WHEREAS, in July 2022, RCAC assisted OPUD in conducting an interest survey of 412 property owners surrounding OPUD's service area and found an interest percentage of 78.8% among respondents who were not already receiving sewer services from OPUD.

WHEREAS, according to OPUD, there is the potential for up to 185 septic-to-sewer conversions in consolidation.

NOW, THEREFORE, BE IT RESOLVED, by the Board Members of the Olivehurst Public Utility District as follows:

The General Manager (the "Authorized Representative") or designee is hereby authorized and directed to sign and file, for and on behalf of Olivehurst Public Utility District, a Financial Assistance Application for a financing agreement from the State Water Resources Control Board for the planning, design, and construction of Consolidation of Private Home Septic Systems with Olivehurst Public Utility District (OPUD) (the "Project").

The Authorized Representative, or his/her designee, is designated to provide the assurances, certifications, and commitments required for the financial assistance application, including executing a financial assistance agreement from the State Water Resources Control Board and any amendments or changes thereto.

The Authorized Representative, or his/her designee, is designated to represent the Olivehurst Public Utility District in carrying out the Olivehurst Public Utility District's responsibilities under the financing agreement, including certifying disbursement requests on behalf of the Olivehurst Public Utility District and compliance with applicable state and federal laws.
